**INDEMNITY FORM**

(PRIVATE)

**INDEMNITY:** I, the undersigned deponent, Parent/Guardian, hereby acknowledge that I have taken note of the provisions of section 85 of the Defence Act No 42 of 2002. I represent myself, my family and the Young Falcon/Aero Tech Cadet indicated below whether he/she is part of my family or I am the Young Falcon / Aero Tech Cadet's Guardian. If I sign as Guardian, I further hereby indicate that I am duly authorised by the immediate family of the Young Falcon/ Aero Tech Cadet to sign as Guardian/Responsible Person in this instance.

In addition, I hereby personally indemnify the State, the South African National Defence Force (SANDF) and all persons in the service of the SANDF or the State of all liability in respect of any and all loss or damage resulting from bodily injury to my person, the persons of my family, the person of whom I have signed as Guardian, the loss of my life, the loss of the life of my family member or members, the loss of the life of the person of whom I have signed as Guardian below, loss or damage to my/our property, or any other damage, caused by or arising out of or in any way connected with any act or omission ordered or performed whether by a member or employee of the SANDF or the State or any other person, while I/we make use of any vehicle, aircraft, vessel or any other property of the State in its Department of Defence or the SANDF, or while I/we make use of any services rendered by the SANDF or the State.

I further personally indemnify Cape Virtual, Association of Virtual Aviation in South Africa, the Aero Club of South Africa, Stellenbosch Flying Club, Cape Gliding Club, Morningstar Flying Club and all related personnel, club members, pilots, aircrew and passengers, whether members of a mentioned club or not, and any other persons so associated, including employees, agents and successors in title, against liability for any damage to property, bodily injury or loss of life to myself, my family or the Young Falcon/Aero Tech Cadet concerned for whom I have signed as Guardian, that may occur during participation in any activities connected with the Young Falcons/Aero Tech Cadet program. Any club or association not mentioned above but participating in the Young Falcons/Aero Tech Cadets activity is included as other persons, entities, groups so associated.

I acknowledge that participation in the Young Falcons/Aero Tech Cadets program and activities may be hazardous and I am fully cognisant of the potential dangers. As far as the Cape Gliding Club is concerned, I hereby apply on behalf of the Young Falcon indicated below for temporary one day membership as per the published current Young Falcons Schedule and agree to be bound by the rules and constitution of the Cape Gliding Club.

**Section 85, Defence Act No 42, 2002**

**85.** (1) Neither the State nor a member is liable (except in the case of any wilful act or omission on the part of a member or employee) to any person who makes unauthorised use of any vehicle, aircraft or vessel under the control of the Department, or to any dependant of such person, for any loss or damage resulting from any bodily injury, loss of life or loss of or damage to property caused by or arising out of or in any way connected with the use of such vehicle, aircraft or vessel.

(2) Neither the State nor a member or employee is liable (except in the case of any wilful act or omission on the part of any such person) in any person –

- (a) Referred to in section 80(3) who makes use of any vehicle, aircraft or vessel which is under the control of the department and appropriated for use by members or employees.
- (b) Who makes use of any other property of the Department: or
- (c) To whom services are rendered by the Department, or to any dependant of such person, for any loss or damage resulting from any bodily injury, loss of life or loss of damage or property caused by or arising out of or in any way connected with the use of any such vehicle, aircraft or vessel, such other property or such services.

(3) If the State has paid any compensation in any respect of a claim by any person for any loss or damage contemplated in subsection (2), the State may, without having obtained any formal session of the right of action, recover from the person responsible for the loss or damage, the amount paid by way of compensation or any lesser amount determined by the Minister with the concurrence of the Minister of Finance.
